

2018 Early Bird Pool Membership Fees and Guidelines

- All rates are based on the number of people in your family. A primary member must be at least 18 years old and in good standing with POSC.
- Any person over 21, who is not the spouse of a primary member, must join separately as a primary member.
- Any person under 18 must join with a primary member. Children under the age of 2 as of May 26, 2018 are free.
- If you have more than 6 members in your family, add \$40.00 for each additional member.
- **Childcare providers** can join for \$75.00 but should attend the pool only while the child is in their care.
- **Senior Citizens** (age 62 and older) receive a 10% discount on their membership.

ID cards will be available at the entrance of the pool beginning Opening Day, Saturday, May 26th. Cards must always be presented for entrance into the pool, and all members and guests should sign in each time they visit the pool. **For additional information, contact Lori Cardone at 757-1021 or jcardone500@comcast.net.**

Guest fee is \$6.00 per guest per visit, or \$3.00 after 6:00pm. All fees should be paid to the lifeguard on duty. There is a 6-visit limit per person per season for non-members. Temporary memberships are available for out-of-town guests desiring more than 6 visits—contact the pool manager for more information. All guests must be accompanied by a POSC member.

Rules are posted at the pool. Anyone not abiding by the rules set forth by the POSC will be warned and/or asked to leave. **Any child under 11 years of age must be supervised by an individual 15 years of age or older. As recommended by the America Red Cross, children 6 years of age and younger must be supervised by an adult pool-side.**
